ARTICLES OF INCORPORATION

OF

POCATELLO GREENHOUSE AND FLORAL, INC.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, all of whom are bona fide residents of the State of Idaho and citizens of the United States of America, and over the age of majority, do hereby associate ourselves for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

I

The name of this corporation shall be POCATELLO GREENHOUSE AND FLORAL, INC.

II

The purposes for which this corporation is formed are as follows:

A. To carry on the business of landscape gardeners, floriculturists, nurserymen, and decorators including any and all construction or alteration work incidental thereto, and all and any kindred pursuits; to grow, cultivate, buy, sell, and import trees, hedges, shrubbery, vines, ferns, evergreens, foliage, grass, and other vegetable growths; and to deal in decorative and emblematical materials and designs, composed either wholly or in part of flowers, vines, ferns, evergreens, leaves, grass, and similar articles. To engage in the general nursing and horticultural pursuits and to purchase, buy, sell, import, and export flowers, plants, trees and shrubbery. To manufacture, buy, sell, exchange, lease, import, export, and generally deal in all kinds of artificial flowers and decorations, vases, urns, and agricultural and horticultural implements and accessories. To acquire, own, conduct, and generally engage in the wholesale and retail florist business.

B. To buy and sell, both at wholesale and retail, export, import, and generally trade in chinaware, dishware, crockery, porcelain ware, glassware, cut glass, books, book ends, candles, candlesticks, doorstops, plaques, greeting cards, jewelry, and other novelties, and all kinds of goods, wares and merchandise of every kind, nature, and description; to conduct one or more gift and miscellaneous novelty shops, and to operate any business along any line cognate to the business herein more specifically described.

C. To prepare, compound, devise and prepare formulae for, manufacture, buy, sell, import, export, and generally deal in and with aerosols and any insecticides, fungicides, germicides, disinfectants, antiseptics, exterminators, deodorants, humidifiers, and all kinds of mineral, chemical and medicinal preparations and materials, whether in the form of liquid, mists, stains, sprays,

fumes, vapors, smoke, powders, dusts, solids, pastes, films or otherwise, necessary, useful, or convenient in commerce, industry, public welfare and health, agriculture, dairy farming, warfare, and in the home and in any and all areas, whether recreational, industrial, commercial, public welfare and health, or agricultural, harboring harmful, injurious, or obnoxious insect life, odors, germs, and other objectionable conditions and substances.

D. To conduct a garden center and to sell all tools, machinery and articles necessary and used in gardening, including spray equipment, and all other equipment generally used in gardening purposes.

E. To purchase, hold and use from time to time as it may see fit, any part of its own stock, using for such purposes any part of its surplus. When this corporation holds the same it shall not be entitled to vote such stock or to receive dividends thereon.

F. To purchase, hold, acquire and sell stock in any other corporation or corporations.

G. To borrow money and execute notes and mortgages therefore and to loan money and to take notes and mortgages to secure the repayment of the same.

H. To take, acquire, buy, hold, own, maintain, control, manage, develop, sell, convey, lease, mortgage, improve, subdivide or otherwise deal in and dispose of real estate and real property or any interest therein.

I. To take, acquire, buy, hold, own, maintain, control, manage, sell, lease, mortgage, improve, or otherwise deal in personal property of all kinds or any interest or rights therein, and to do all things incident to or connected with any of the aforesaid purposes which might further or aid the purposes and objectives as aforesaid.

III

The period of existence of this corporation shall be perpetual.

IV

The location and post office address and the registered office of this corporation shall be Pocatello, Bannock County, State of Idaho.

V

The business and prudential affairs of this corporation shall be managed by a Board of Directors. The number of the Board of Directors of this corporation shall be three, who have been chosen from the shareholders of the corporation; provided, however, it shall not be necessary for a Director of this corporation to be a stockholder thereof.

VI

The amount of the capital stock of this corporation shall be ONE HUNDRED FIFTY THOUSAND DOLLARS (\$150, 000.00) divided into fifteen hundred (1500) shares of the par value of One Hundred Dollars (\$100.00) per share. The amount of capital stock which has actually been subscribed and paid for is Four Hundred Dollars (\$400.00) by the following named persons, with the amount of stock of each:
