ARTICLE 1

The corporation formed herein shall be known, from the date of it's incorporation until later altered or said corporation is dissolved, as CENTURY ROCK PRODUCTS, INC.

ARTICLE II

The corporation herein formed shall have a perpetual duration and shall remain in existance according to the laws of the State of Idaho until such time as said corporation is effectively dissolved by voluntary will, or by operation of law.

ARTICLE [] [

The purpose of the corporation herein formed shall be to transact all lawful business, for which operation may be formed in the State of Idaho, as from time to time said corporation may deem desirable for benefit of said corporation; said benefits to be the exclusive discretion of the Directors.

ARTICLE [V

There shall be only one class of stock, known as common stock, issued by the corporation, which shall be non-assessable.

ARTICLE V

The corporation shall be authorized to issue 5,000 shares of capital Common Stock as a par value of \$100.00 per share.
