The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Nascent, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is formed is to acquire by purchase, lease, gift, devise, or otherwise, and to own, manage, use, hold, sell, convey, exchange, lease, mortgage, work, improve, develop, divide, and otherwise handle, deal in, and dispose of real estate, real property, and any interest or right herein, whether as principal, agent, broker, or otherwise, and to manage, operate, service, equip, furnish, alter, and keep in repair condominiums, dwellings, apartments houses, hotels, office buildings, and real and personal property of every kind, nature, and description, whether as principal, agent, broker, or otherwise, and generally to do anything and everything necessary and proper and to the extent permitted by law in connection with the owning, managing, leasing, of real estate and real estate properties.

To acquire by purchase, lease gift, devise or otherwise, and to own, manage, use, hold, sell, convey, exchange, lease, mortgage, work, improve, develop, and otherwise handle, deal in, and dispose of computer services, office supplies, consulting services, cleaning and maintenance services, construct, and any interest or right herein, whether as principal, agent, broker, manufacturer's representative, independent contractor, and generally to do anything and everything in connection with the owning, managing, leasing of these services.

To exercise any and all rights and powers which a corporation formed under the laws of the State of Idaho may now or hereafter exercise.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue shall be five thousand (5000). The shares of the stock shall have no par value.

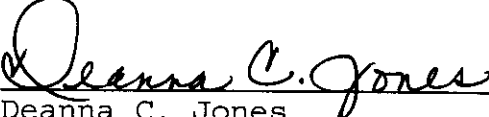
