The undersigned, Keith Wayment, P.A., of 1218 9th Street, Suite #4, Rupert, Idaho 83350, does hereby form a corporation, hereinafter referred to as the "Corporation" under the general laws of the State of Idaho, including particularly the Professional Service Corporation Act, hereinafter referred to as the "Act", and adopts the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation is Keith Wayment, P.A.

ARTICLE II

Purposes

The purposes for which the corporation is formed are as follows:

(1) To engage in the practice of medicine as a medical corporation and to own and operate a medical clinic for the purposes of providing medical care and treatment.

(2) To promote medical, surgical, and scientific research and knowledge; to furnish related laboratory and clinical services; to invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment and to own real and personal property, to enter into contracts, and to engage in any lawful business necessary for the rendering of such professional services.

(3) To do everything necessary, proper, or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act and thing incidental thereto that is not forbidden by the laws of the State of Idaho or by the provisions of these Articles of Incorporation.

The professional purposes of this corporation shall be carried out only through officers, employees, and agents who are duly licensed or otherwise legally qualified in the State of Idaho to render professional medical services.

ARTICLE THREE

Principal Office and Resident Agent

ARTICLE FOUR

Management of Corporation

The number of directors of the corporation shall be one (1), which number may be increased or decreased pursuant to the bylaws of the corporation, but shall never be less than one (1). the name and address of the person appointed to act as director until the first annual meeting or until a successor is duly chosen and qualified is Keith Wayment.

ARTICLE FIVE

CAPITAL STOCK

The number of shares of stock which the corporation is authorized to have outstanding is one thousand (1,000) shares, said shares shall all be common stock and without par value.
