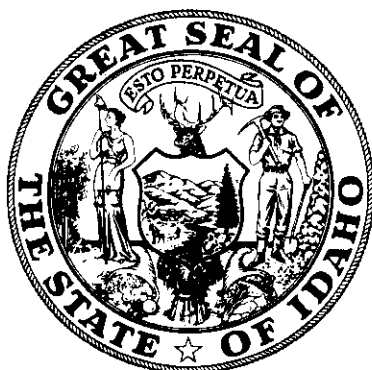



BE IT FURTHER RESOLVED,


