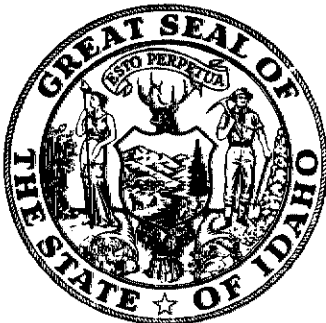

The undersigned, acting as incorporator of Idaho Great Basin Trucks, Inc., a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Idaho Great Basin Trucks, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act and as such may be amended.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is five hundred thousand (500,000) shares of common stock of a par value of \$1.00 per share, an aggregate total capital of FIVE HUNDRED THOUSAND AND NO/100 DOLLARS (\$500,000.00).

FIFTH: Provisions denying preemptive rights are: There are no preemptive rights.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: The By-Laws shall set the number of and qualifications of Directors and Officers and shall set forth any restrictions, if any, on the transfer of shares.

SEVENTH: The address of the initial registered office of the corporation is 7455 Federal Way, Boise, Idaho 83706 and the name of its initial registered agent is A. J. Bohner whose mailing address is Post Office Box 1069, Boise, Idaho 83704.

EIGHTH: The number of directors constituting the initial Board of Directors of the corporation is as set forth in the By-Laws, and the name and address of the person who is to serve as Director until the first

successor or successors are elected and shall qualify is:
