ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

NORTHSIDE CHURCH OF CHRIST, INC.

A meeting of the members was held on the FIFTH day of JANUARY, of 1986, at 1803 South Maple Grove Rd., Boise, Idaho and a quorum of members of the corporation were present and the following amendments received a majority of the votes which said members were entitled to cast:

ARTICLE I was amended to read as follows:

The name of this corporation is MAPLE GROVE Church of Christ, Inc., a nonprofit religious association.

ARTICLE VI was amended to read as follows:

Every other person who is now a member of the MAPLE GROVE Church of Christ, Inc., of Boise, Idaho, or who shall hereafter become a member of said church, shall, by virtue of said membership in the church, be a member of the corporation, and his membership in the corporation shall cease upon the termination of his membership in said church.

ARTICLE VII, second paragraph, was amended to read as follows:

The members of the Board of Trustees shall be elected annually at the annual corporation meeting, which shall be held on the FOURTH Sunday in January and shall hold office until their successors are elected. The officers of this corporation shall hold office for one year and shall be elected at the annual corporation meeting by the Board of Trustees; said officers shall hold office until their successors are elected.

ARTICLE X, first paragraph, was amended to read as follows:

The Board of Trustees shall meet in regular session of the FOURTH Sunday of each month and may hold special meetings at any time the president may call the same upon the giving of twenty-four (24) hours written notice to each of the directors or upon each director signing a waiver of notice thereof.

WE, the undersigned, being respectively the President and Secretary of the Maple Grove Church of Christ, Inc., a corporation, do hereby certify that the foregoing Articles of Amendment were adopted as such by the members of the corporation at said meeting.
