(B) The general purposes and powers are; those possessed by nonprofit corporations.

## **DEFINITION:**

Hydroenterology is a system of emptying the large bowel (Colon) of accumulated waste material by water irrigation, and returning the colon to a normal state by the use of heat, light, counseling, diet, and any other method compatible with the body's normal functions except prescription drugs or surgery.
