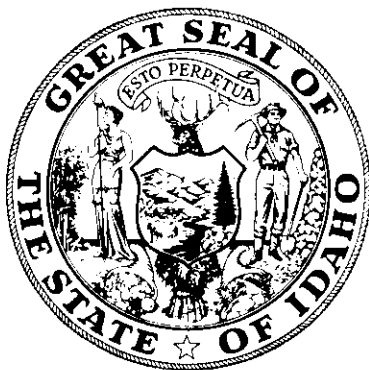

1 ARTICLES OF INCORPORATION

4 The undersigned, acting as incorporators of a corporation
5 under the Idaho Business Incorporation Act, adopt the following
6 Articles of Incorporation for such corporation:

7 FIRST: The name of the corporation is: BELL RAPIDS
8 SUPPLY CO.

9 SECOND: The period of its duration is perpetual.

10 THIRD: The purpose or purposes for which the corporation
11 is organized are:

12 (a) To engage in the business of manufacturing, buying,
13 selling, distributing, leasing, servicing, repairing, and otherwise
14 dealing in irrigation equipment and supplies and all other
15 agricultural implements, vehicles, materials, machinery, buildings,
16 equipment and supplies, and in implements, vehicles, materials,
17 supplies, machinery and equipment of allied lines in its own name
18 and as agent for or on consignment from other business entities.

19 (b) To carry on any other kind of business or business
20 activities that the Board of Directors may from time to time deem
21 to be advisable or proper in connection with the supply business.

22 (c) To purchase, lease, own, sell, mortgage, sublease,
23 and otherwise acquire lands, buildings, easements or property, real
24 and personal, which may be requisite for the purposes or are
25 capable of being conveniently used in connection with any of the
26 objects of this corporation, and to enter into, make, perform and

1 carry out contracts of every sort and kind with any person, and to
2 acquire and take over the good will, property, rights, franchises
3 and assets of every kind and the liabilities of any person, firm,
4 association, or corporation, either wholly or in part, and to pay
5 for the same in cash, stocks or bonds of the corporation, or
6 otherwise.

7 (c) In the purchase of or acquisition of property,
8 business rights or franchises or for any other object in and about
9 its business or affairs, to incur debt and to borrow and secure the
10 payment of money in any lawful manner including the issue and sale
11 or other disposition of bonds, debentures, notes and other
12 evidences of indebtedness.

13 (d) Without in any particular way limiting any of the
14 objects or purposes or powers of the corporation, the business or
15 purposes of the company shall be empowered from time to time to do
16 any one or more or all of the acts and things herein set forth and
17 to engage in the general commercial business, and all such other
18 acts, things and business in any way connected therewith or
19 auxiliary thereto.

20 (e) To transact any and all lawful business for which
21 corporations may be incorporated under the Idaho Business
22 Corporation Act.

23 FOURTH: The aggregate number of shares which the
24 corporation shall have authority to issue is:
