

ARTICLES OF INCORPORATION
OF FIRST CHURCH OF CHRIST, SCIENTIST,

OF
COEUR D'ALENE, IDAHO.

WITNESSED AND SUBSCRIBED BY THREE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

I

The name of said corporation is "First Church of Christ, Scientist, of Coeur d'Alene, Idaho.

II

The purpose for which said corporation is formed is the carrying on and conducting public worship, and the benevolent purposes connected therewith, according to the tenets of the religious denomination known as "Christian Scientist", and subject to the provisions of the manual of the Mother Church, First Church of Christ, Scientist, of Boston, Massachusetts, by Mary Baker Eddy, also to acquire, hold and use all such real estate and other property as may be reasonably necessary for the purpose of carrying into effect the objects hereinbefore mentioned.

III

The place where the principal business of said corporation is to be transacted is Coeur d'Alene, Kootenai County, Idaho.

IV

The time for which said corporation is to exist is fifty years from and after the date of incorporation.

V

That the estimated value of the property owned by the Christian Science Society of Coeur d'Alene Idaho, and which will become the property of First Church of Christ, Scientist, of

Coeur d'Alene, Idaho, by this incorporation, is Twenty-five Hundred Dollars (\$2500.00)

VI

The directors having the control and management of the business of said corporation are five in number, and the names, residences and terms of office for which said directors were elected are as follows, to-wit:

December 22, 1914; that notice of said meeting for the election of said Directors was published in the Journal, a semi-weekly newspaper published in the city of Coeur d'Alene, Idaho, and circulating in Kootenai County, Idaho, for a period of two full weeks prior to said election, and that a notice of said election was posted in a conspicuous place on the church building of the Christian Science Society of Coeur d'Alene, Idaho, corner of 3rd and Foster streets, for two weeks prior to said election, and that a majority of the members of said association were present and voted, and the result thereof was the election of the Directors above mentioned
