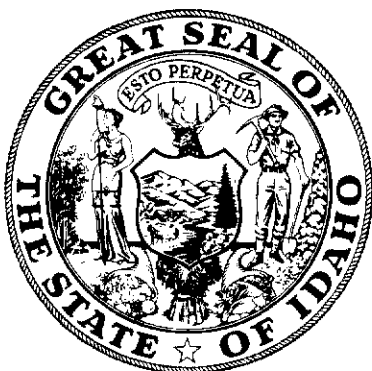

ARTICLE I 87 JAN 27 AM 9 03
NAME

The name of the corporation is: VENTURE UNITED SOCCER
CLUB, INC.

ARTICLE II
STATEMENT OF NON-PROFIT

The corporation is a non-profit corporation.

ARTICLE III
DURATION

The period of duration is perpetual.

ARTICLE IV
PURPOSES

The purpose for which this corporation is organized is to
encourage, develop, promote and administer the game of soccer and
'all related activities.'

ARTICLE V
AUTHORITY TO ELECT

This corporation will have members and no corporation or
church or religious association will have authority to elect
directors pursuant to subsection (b) or (e) of Section 30-314
Idaho Code.

ARTICLE VI
MANAGEMENT OF AFFAIRS

The corporation will not vest in its member's management powers pursuant to Section 30-314(c) of the Idaho Code.

ARTICLE VII
BY LAWS

The internal operation of the corporation shall be consistent with the By Laws of the corporation.
