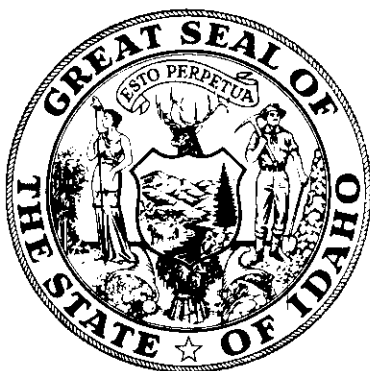

ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION

The undersigned natural person, THOMAS G. SKINNER, acting as president, and JACQUELYN L. SKINNER, acting as secretary of Skinner Enterprises, Inc., an Idaho corporation, under the provisions of the Idaho Business Corporation Act (this Act as amended from time to time is referred to herein as the "Act"), do hereby declare that the following amendments were made and adopted on the 21st day of June, 1982, by an unanimous vote of all of the shareholders of the corporation, being 100 shares, all entitled to vote thereon.

A. Amendment 1: Be it hereby enacted that Article 1 of the Articles of Incorporation is amended to read as follows:

"Article 1

Name

The name of this Corporation shall be and is T. SKINNER ENTERPRISES, INC."

B. Amendment 2: Be it hereby enacted that Article 6 of the Articles of Incorporation is amended to read as follows:

"Article 6

Aggregate Shares

The aggregate number of shares that the corporation shall have the authority to issue is One Thousand (1,000) shares of capital stock with a par value of One and No/100ths Dollars (\$1.00) per share, which stock shall be non-assessable, with each share of stock to be entitled to one vote."

Notice is hereby given that Amendment "B" as set forth above effects a change in the amount of stated capital by increasing the same from \$100.00 to the sum of \$1,000.00.


