

ARTICLES OF INCORPORATION

I.

The name of the corporation is "EQUIFAX INC."

The corporation shall have perpetual duration.

III.

The corporation is a corporation for profit and is organized for the following general purposes: to form or acquire interests in or control of other corporations; to participate with others in any corporation, partnership, transaction, arrangement, operation, organization or venture, even if such participation involves sharing or delegation of control with or to others; and to engage in any lawful act or activity for which corporations may be formed under the Georgia Business Corporation Code.

TV.

The corporation shall have authority, acting by its Board of Directors, to issue not more than 1,000 shares of common stock having a par value of \$1.00 per share.

The corporation shall not commence business until it shall have received at least \$1,000 in payment for the issuance of its stock.

VI.

The holders of shares of the corporation's stock shall not have any preemptive rights to acquire any unissued

shares of its stock.


