KNOW ALL MEN BY THESE PRESENTS, That we, Ronald W. Bishop, Jeffrey P. Bishop, and Gary G. Bishop, each of whom are residents of and citizens of the United States, do hereby associate ourselves together for the purposes of forming a corporation under the general incorporation laws of the state of Idaho, and do make, execute and adopt in duplicate the following Articles of Incorporation, to-wit:

ARTICLE I

The name of the corporation shall be ALL STAR VIDEOTAPING, INC.

ARTICLE II

The principle place of business and the registered post office of the corporation shall be 7881 Cross Fox, Boise, Idaho 83709. The name of the registered agent at this address is Ronald W. Bishop.

ARTICLE III

The object and purposes for which this corporation is formed are as follows:

1. To own, lease, operate, manage and do all things necessary to produce video tapes and recordings for consumer and commercial markets including, but not limited to, any and all functions incident to any of the above and in addition, to own, lease, operate and manage videotaping equipment, together with like equipment and all incidents relating thereto, together with any and all things reasonable and necessary and in furtherance of the objectives of the corporation.

ARTICLE IV

The period of duration of the corporation shall be perpetual.

ARTICLE V

The number of shares of stock which the corporation shall have authority to issue shall be 100 shares. These shares will be one class and all of such shares are without par value.

ARTICLE VI

The number of directors of the corporation shall be not less than 3 and not greater than 6. The initial board of directors shall be 4 and will serve as directors until the first annual meeting of shareholders or until their successors be elected and qualify.
