AMENDMENTS TO THE ARTICLES OF INCORPORATION OF THE IDAHO GOVERNOR'S CUP SCHOLARSHIP FUND, INC.

Pursuant to the provisions of §30-326 and §30-327 of the Idaho Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to the Articles of Incorporation:

FIRST: The name of the corporation is the Idaho Governor's Cup Scholarship Fund, Inc.

SECOND: The following amendments of the Articles of Incorporation were adopted by members of the corporation on this 1st day of March, 1988, and in the manner prescribed by the corporation bylaws, its Articles of Incorporation in the manner prescribed by the Idaho Non-Profit Corporation Act, whereby two thirds of the members entitled to vote thereon at the specially scheduled meeting held on this 1st day of March, 1988, hereby adopted the following amendments to the original Articles of Incorporation which is set forth herein.

THIRD: Article IV of the Articles of Incorporation is modified to add a separate paragraph F which reads as follows:

"F. The Idaho Governor's Cup Scholarship Fund, Inc., is organized exclusively for charitable, educational, eleemosynary and humanitarian purposes within the meaning of §501(c)(3) of the Internal Revenue Code."

AMENDMENT OF ARTICLES OF INCORPORATION - P. 1

FOURTH: Article VII of the Articles of Incorporation is amended as follows: "The members of this corporation shall have the power by at least a majority of the members present or represented by proxy at such regularly scheduled or specially scheduled meeting as are entitled to vote to repeal, amend, or adopt the Articles of Incorporation. The Board of Directors of this corporation shall have the power by at least a majority of the entire Board present to repeal or amend the bylaws of this corporation or adopt new bylaws; and provided further that the Board of Directors shall not make or alter any bylaws fixing their number, classification, qualification, term of office, compensation."

FIFTH: Article IX of the Articles of Incorporation is amended as follows: "Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) By corporation exempt from Federal Income Tax under §501(c)(3) the Internal Revenue Code of 1986 (or the corresponding provision of any United States Internal Revenue law); or, (b) By corporation, contributions to which are deductible under §170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any United States Internal Revenue law).

SIXTH: All remaining provisions of the Articles of Incorporation, dated June 2, 1987, remain unchanged.
