KNOW ALL MEN BY THESE PRESENTS, that we, B. L. Steeves, F. S. Harding, E. M. Heigho, M. W. Hunt and Edward Shainwald being residents and freeholders of Washington County, Idaho, do hereby make and subscribe to the following Articles of Incorporation.

I.

The name of this corporation shall be the Signal ~~Printing and~~ Publishing Company, Limited.

II.

The purposes for which this corporation is formed shall be to publish and circulate newspapers and to do a general publishing and printing business and to own stock or interests in other corporations, companies or concerns, and to purchase, own or control real or personal property and to rent, lease, mortgage sell or hypothecate the same as the interests of said Corporation may dictate.

III.

The place where the principal business of this Corporation is to be transacted shall be Weiser, Washington County, Idaho.

IV.

The term for which this Corporation shall exist shall be fifty years.

V.

The number of Directors of this Corporation shall be five, the following named Stockholders being hereby named as such Board of Directors for a period of one year from the date of the filing of these Articles, to wit:-

B. L. Steeves, F. S. Harding, E. M. Heigho, M. W. Hunt and Edward Shainwald, each and all residing in Weiser, Washington County, Idaho.

VI.

The amount of the capital stock of this Corporation shall be Fifteen Thousand (\$15,000.00) dollars, and shall be divided into one hundred and fifty (150) shares of the par value of One Hundred (\$100.00) dollars each.

VII.

The amount of the capital stock of this Corporation actually subscribed at the date of the execution of these Articles of Incorporation, is the sum of Eight Thousand (\$8000.00) dollars, and is subscribed by the following named Stockholders, to wit:-
