Carretta C. Chewrart and Maynard
associate ourselves together for the purpose
of becoming a body corporate under
and by virtue of the laws of the state of
Idaho. Witnesses.

1st The name of our said corporation shall
be The Union Congregational Church
of Summit, Nez. Perce Co. Idaho.

2nd The purpose of said corporation is to
carry forward the preaching^{2d} teaching
of the gospel of Jesus Christ and
the promotion of such enterprises as
will best serve that purpose.

3rd The place where its principal
teaching and preaching is to be done, is in
Summit, Nez. Perce County Idaho.

4th The term for which this said corporation
is to exist is not to exceed fifty (50) years.

5th The number of its trustees is to be five
(5) And those elected to serve for the first year

or until January 1904 and their names

and A. F. McCullum all of Summit Idaho.
