ARTICLES OF INCORPORATION
OF
BONNERS FERRY BOXING CLUB,
INC.

KNOW ALL MEN BY THESE PRESENTS: That we, whose names are hereto affixed, all of whom are bona fide residents and full-age citizens of the United States of America, do under and in pursuance of Idaho Code Sections 30-301, et seq. and general corporation laws of said State, hereby organize, constitute and associate ourselves in accordance with these Articles, into a body politic, and corporate not for profit for the purposes hereinafter set forth and to that end we execute these Articles of Incorporation, and hereby certify, set forth and declare as follows:

I.

N A M E

The name of this corporation is the BONNERS FERRY BOXING CLUB, INC.

II.

The purposes of this Organization shall be:

To promote and encourage the sport of boxing; to bring together those boys who are interested in participating in the sport of boxing, and to promote and encourage the sport, pleasure, exercise and recreation of such persons; to teach,

conduct boxing clinics and boxing matches or meets in furtherance of the purposes of this corporation; to manage and conduct entertainments, excursions, and social meetings of such boys; to lease and/or procure training and operating facilities, material, and equipment for the carrying out of any of the purposes of this corporation;

To solicit donations from the public to accumulate funds to cover or defray expenses connected with the operation of such corporation and to charge an attendance fee for spectators viewing any boxing meet or match carried on in furtherance of the purposes of this corporation to cover or defray such expenses;

To educate and disseminate information relative to the foregoing purpose.

To acquire by gift, devise, grant and purchase real and personal property and to sell, encumber and otherwise dispose of the same for the benefit of this organization, and/or to use it for the purposes thereof.

To be a non-profit corporation for the welfare of the general public.

To generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform so long as in conformance with the other purposes herein enumerated.

To engage in the business of buying, acquiring, giving, owning, leasing, transferring, encumbering and generally dealing in real and personl property so long as in conform-

The purposes herein shall be construed both as purposes and powers and shall be in no wise limited or restricted by reference to, or inference from the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or of the general powers of the corporation, nor shall the expression of one thing be deemed to exclude another, although it be of like nature unexpressed.

To do all and every thing necessary, suitable, and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms or individuals, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects and purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized; and also so long as in conformance with the other purposes herein enumerated.

III.

The duration of the corporation is perpetual.

IV.

The location is Boundary County, Idaho, and the post office address of the registered office of the corporation

Bonners Ferry, Idaho, 83805, and the name of the registered agent is Richard Dawson.

V.

There shall be two classes of members of this non-profit corporation:

- A · Participating members
- B Voting members which consist solely of the president and secretary, officers of this non-profit corporation

VI.

The corporate powers and the management of the affairs of this non-profit corporation shall be vested in a Board of Directors, the members of which shall be two (2).

The first such directors, who shall hold office for life, or until appointment of new directors in the manner and for the term as provided in the bylaws, shall be:

The powers and duties of the officers of this corporation shall be as prescribed in the bylaws.

VII.
