AMENDMENT TO ARTICLES OF INCORPORATION
OF
PLANNED PARENTHOOD ASSOCIATION OF IDAHO, INC.

The Articles of Incorporation of this corporation are hereby amended by the deletion of Article III in its entirety and the substitution of the following Article III:

"ARTICLE III

"The purposes for which said non-profit corporation is formed are:

- "(a) For charitable purposes within the meaning of §501(c)(3) of the Internal Revenue Code of 1954.
- "(b) To provide family planning, birth control and pregnancy counselling to the general public.
- "(c) To educate the general public concerning family planning and the problems of overpopulation.
- "(d) To work in conjunction with existing federal, state and local family planning clinics and to establish and operate family planning clinics for the purpose of family planning, birth control and pregnancy counselling, and provision of the necessary services in connection therewith.
- "(e) To have and exercise all of the powers granted to non-profit corporations organized under the laws of the State of Idaho which are necessary in order to carry out the foregoing purposes."

The Articles of Incorporation of this corporation are further amended by the addition of the following sentence at the end of Article X following the words, "shall likewise be exempt:"

"In the event that Planned Parenthood Federation of America or its successor organization is not then exempt from federal taxation, said

assets and property of this corporation shall be donated to and vest in another organization exempt from federal taxation under IRS Code §501(c)(3)."

WE, THE UNDERSIGNED, being all the Directors of this corporation, for the purpose of amending said Articles of Incorporation of this corporation, in accordance with the laws of the State of Idaho, do hereby make, file and record this Amendment to Articles of Incorporation and do certify that the facts herein stated are true, and accordingly we have hereunto set our respective hands and seals this 26th day of October, 1971.


