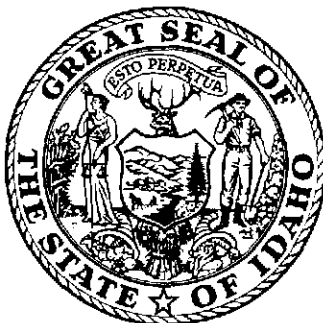

RE: Use of "bank" in company name

Dear Mr. Gibson:

The Idaho Department of Finance (Department) has received your letter and email, dated December 4, 2014, requesting a no-objection position by the Department for use of the name "Interbank-Exchange, LLC d/b/a Interbank-Equipment" (Interbank) in the state of Idaho. We understand that Interbank wishes to register as a foreign corporation in Idaho and engage in the business of selling security-related equipment to banks and other entities such as hotels, hospitals, national and local government agencies, etc. We further understand that Interbank is not a bank, does not engage in, and does not intend to engage in the business of banking in Idaho.

Section 26-1202 of the Idaho Bank Act prohibits any person, other than a national bank, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. The Idaho Bank Act does not authorize the Director of the Idaho Department of Finance to waive the requirements of the law. Rather, the Department is offering "no objection" to the company's use in Idaho of the name "Interbank-Exchange, LLC d/b/a Interbank-Equipment." Under the circumstances discussed above, we do not believe the proposed use of the name "Interbank-Exchange, LLC d/b/a Interbank-Equipment" in Idaho is misleading to the public. While the Department does not intend to pursue an action under this statute, it is possible that another agency may do so. However, we believe the likelihood is slight.
