ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as incorporator under the provisions of the Idaho Business Corporation and the Professional Service Corporation Act, adopts the following Articles of Incorporation:

1. NAME. The name of the corporation is SUSAN DESKO, P.C.
2. DURATION. The period of its duration is perpetual.
3. PURPOSES. This Corporation is a professional service corporation as defined by Idaho Code §30-1303. The Corporation is organized under the Professional Service Corporation Act for the sole and specific purpose of rendering professional service and shall have as its shareholders only natural persons who themselves are duly licensed or otherwise legally authorized within the State of Idaho to render the professional services authorized to be conducted in the corporate form as provided for by the Professional Service Corporation Act. The Professional Service of this Corporation is Architecture.

As provided by Idaho Code §30-1307, this corporation shall not engage in any business other than the rendering of the professional services for which it was specifically incorporated; provided, however, that the Corporation shall be allowed to invest its funds in real estate, mortgages, stocks, bonds or any other type of investments, and may own real or personal property necessary for the rendering of professional services and conduct any such other business as it may not be specifically prohibited by law.

4. STOCK. The Corporation shall have the authority to issue one thousand (1,000) shares of capital stock, all of one (1) class, ONE DOLLAR (\$1.00) par value.



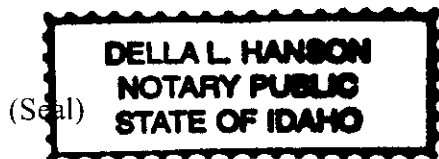
