

ARTICLES OF INCORPORATION  
OF

C. J.'S AUTO & TRUCK REPAIR, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following articles of incorporation:

I.

The name of the Corporation is: C. J.'S AUTO & TRUCK REPAIR, INC.

II.

The Corporation is to have perpetual existence.

III.

The Corporation is organized for the purpose of Automotive Repair, and for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The authorized capital of the corporation consists of a single class of stock, the total number of authorized shares is 100 with a par value of \$ None, and an aggregate par value of \$ None.
