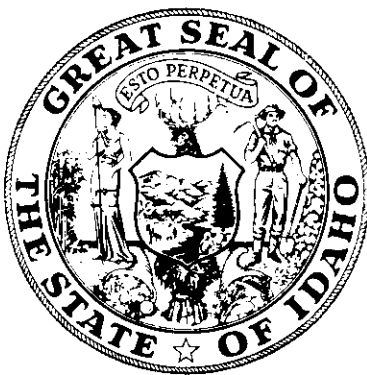

Section 1. There are not suits pending against K & L Inc. in any court.


ARTICLE VII. CONSENT


