RESTATED ARTICLES OF INCORPORATION OF LEWISTON GOLF AND COUNTRY CLUB, INC.

FIRST:

That the corporate name of this corporate

"LEWISTON GOLF AND COUNTRY CLUB, INC."

SECOND:

The purposes and objects for which said corporation is formed

are as follows:

- A. To promote, foster and encourage good fellowship and sportsmanship among the members of this organization;
- B. To provide its members with a club, recreation, reading, dining, refreshment and game rooms; to provide a place for members to meet socially and to encourage social activities and relations between its members;
- C. To promote and encourage outdoor sports and athletic activities;
- D. To promote, foster and encourage the playing of golf among the members of the organization and to provide said members with golfing grounds and facilities for the playing of golf, and to provide other recreational sports and games for said members;
- To lease, buy, acquire, own and hold any real and/or personal property in the State of Idaho, which may be requisite, necessary or convenient for its use for any of its purposes aforesaid, and capable of being used in connection with the objects and purposes of the association, and also to mortgage, hypothecate, transfer, lease, exchange, trade and/or dispose of any of such real and/or personal property whenever it shall be in the interests of the corporation to do so;

F. To exercise generally any and all powers which are incidental to or are in furtherance of any of its purposes which are permitted to it under the laws of the state of Idaho, and not inconsistent with the provision of Chapter 3 of Title 30 of the Idaho Code, as now existing or hereafter amended governing Idaho non-profit corporations.

The foregoing clauses, by reason of the specific enumeration of such powers, shall not be held to restrict the power of the corporation to do any act or thing within the purview of its general purposes.

THIRD: The number of Directors of the Board of Directors of the corporation shall be seven (7) and the number of Directors of the corporation may be changed as designated in the Bylaws of the corporation. Only individual persons may be directors and no person shall be deemed qualified to hold office as a director of the corporation unless they are a Voting Member or the spouse of a Voting Member in good standing at the time of their nomination, election, or appointment and during the entire tenure of the term for which they are elected to serve as director of the corporation.

Directors shall be elected in such manner and for such terms as shall be provided in the Bylaws of the corporation.

FOURTH: The corporation shall have its principal place of business in Nez Perce County, Idaho. The principal offices of the corporation are located at 3985 Country Club Drive, Lewiston, Idaho 83501 and the registered agent of the corporation shall be Laverne Johnson.

FIFTH: The term for which the corporation shall exist shall be perpetual.

SIXTH: The corporation shall have members and may issue memberships as set forth from time to time in its Bylaws. The corporation may issue memberships only to natural persons and no membership may be held, issued or transferred to any corporation, trust, limited liability company, limited or general partnership or organization of any kind. The corporation shall not issue more than one (1) membership to any person.

SEVENTH: The corporation shall have as officers a President, a Vice President, a Secretary and a Treasurer, who shall be elected in such manner and for such terms as shall be provided in the Bylaws of the corporation.

EIGHTH: The Bylaws of the corporation shall, in addition to other provisions as may be required by law, provide for:

- A. The number, qualification and classification of members and terms and conditions of admission to membership.
- B. The method, procedures and effect of expulsion, suspension or withdrawal from and of restoration to membership.
- C. The method and procedure for the transfer of certain memberships upon the death or withdrawal of a member.
- D. A method for determining fees for admission, assessments or dues to carry on the business of the corporation and reimbursement for services rendered and expenses incurred by the corporation for its members; and
- E. Other regulations not repugnant to the laws of the state and consistent with the objects of the corporation.
