ARTICLES OF INCORPORATION
OF
NORTHWOODS PERFORMING ARTS, INC.

That we, the undersigned persons, acting as the incorporators of a corporation under the provisions of and in accordance with the Idaho Non-Profit Corporation Act, 30-201 et seq., and consistent with the provisions of the Internal Revenue Code Section 301 (c) (3), do hereby form and incorporate ourselves into a voluntary association for the purposes set forth herein and adopt the following Articles of Incorporation for such corporation.

ARTICLE I: NAME

This corporation shall be known as the Northwoods Performing Arts, Inc., by which name it shall contract and be contracted with, sue and be sued, and transact all of its business.

ARTICLE II: NON-PROFIT CORPORATION

The Northwoods Performing Arts Corporation shall be a non-profit corporation.

ARTICLE III: DURATION OF THIS CORPORATION

The period of duration shall be perpetual.

ARTICLE IV: PURPOSES

The purposes of this corporation shall be to promote and provide opportunities for entertainment in the realm of music, drama, and dance.

ARTICLE V: MEMBERS

This corporation is to have members and the management of its affairs shall be delineated in its by-laws.

ARTICLE IX: INCORPORATORS

The names and addresses of the incorporators of this corporation are the same persons and addresses listed in article VIII hereof.
