I, the undersigned, being a natural person of full age, and a citizen of the United States or of its territories or possessions, have this day executed these Articles for the purpose of forming a private corporation under the laws of the State of Idaho and to that end hereby adopt these Articles of Incorporation as follows:

ARTICLE ONE NAME OF CORPORATION

The name of the corporation is Timber-Line Corporation.

ARTICLE TWO PURPOSE OF INCORPORATION

The nature of the business and the objects and purposes to be manufacture, market, research, sale, trade, import and export forestry timber related products, and carried on by the corporation are to do any and all of the things herein mentioned as fully and the same extent a natural person might or could do in any part of the world as follows:

To transact any or all lawful business for which corporations may be incorporated under the "Idaho Business Corporation Act" as it is presently constituted or may hereinafter be amended.

ARTICLE THREE DURATION

The duration of the corporation is perpetual.

ARTICLE FOUR REGISTERED AGENT AND REGISTERED OFFICE

The initial registered agent of the corporation shall be W. Brent Eames and the initial registered office shall be located at 41 Professional Plaza, Rexburg, Idaho 83440.

ARTICLE FIVE STOCK

The total number of par value shares which the corporation shall have authority to issue is 100 shares each having a par value of \$100.00, the aggregate par value of the total authorized number of par value shares is \$10,000. There are no authorized shares without par value.

The stock of the corporation is divided into 100,000 shares of a single class, each share having equal rights and each share having one vote. All stock when fully paid for shall be non-assessable.

ARTICLE SIX BOARD OF DIRECTORS & BY LAWS

The corporation shall have the power to established a Board of Directors and adopt appropriate By-Laws of the corporation. The Board of Directors shall have the authority to amend the By-Laws of the corporation by a vote of the majority of the Board of Directors.
