## CERTIFICATE OF AMENDMENT of the ARTICLES OF INCORPORATION of the SABINA MINING AND MILLING COMPANY

WE, THE UNDERSIGNED, E. J. Duff	, Chairman,
and B. J. Farrell , Secretary, of a special m	meeting of
the stockholders of the Sabina Hining and Milling Co	mpany held
for the purpose of amending the Articles of Incorpor	ation of
said company, do hereby certify that notice was give	n to the
stockholders of said corporation of a meeting to be	held at
2 o'clock P. M. on the 15th day of September, 1917,	at Room
Number 3 of the Stanley Hotel in the City of Wallace	, Shoshone
County, Idaho, for the purpose of amending the Artic	les of In-
corporation of said company by providing therein tha	t the stock
of said co pany chall be assessable rather than non-	ossessable,
which said notice was signed by the secretary and wa	s published
in the wallace Miner, a newspaper of general circula	tion in Sho-
shone County, Idaho, published in Wallace, Idaho, wh	ere the prin-
cipal office of said corporation is located.	. •

That said notice as published was in the following words and figures, to-wit:

"Notice of Special Meeting of Stockholders of Sabina Mining and Milling Company.

"Notice Is Hereby Given, that pursuant to a resolution adopted by the Board of Directors of the Sabina Mining & Milling Company at a meeting thereof held on the 4th day of August, 1917, a special meeting of the stockholders of said company will be held at the office of said company in Room 3, of the Stanley Hotel, in the City of Wallace, Shoshone County, Idaho, at 2 o'clock P. M. on the 15th day of September, 1917;

"That said meeting is called for the purpose of considering and acting upon the proposition of amending Paragraph VI, of the Articles of Incorporation of said company, by providing therein that the stock of said company shall be assessable rather than non-assessable, as now provided in said Articles of Incorporation.

Dated at Wallace, Idaho, this 4th day of August, 1917. EVERETT E. HATCH Secretary." We further certify that the said notice was published as aforesaid at least once a week in said Wallace Miner for at least thirty (30) days prior to said meeting, and that a true and correct copy of such notice was also mailed, postage prepaid, to each stockholder of said corporation at the last known post office address.

That at the time and place specified in such notice, the stockholders of said corporation appeared in person and by proxy in numbers representing 791,130 shares of stock of such corporation, and organized said meeting by choosing from their number the undersigned E. J. Duff as chairman, and B. J. Farrell , as secretary thereof.

That thereupon the above notice of meeting was read and the proof of publishing thereof was presented.

Thereupon the following resolution was introduced:

RESOLVED, That the Articles of Incorporation of the Sabina Mining and Milling Company be, and the same hereby are amended by striking out all of the remaining portion of the sixth paragraph commencing with the following words:

"This stock is declared to be fully paid and non-assessable;"

so that said paragraph, when amended will read as follows:

"Sixth: The amount of the capital stock of this corporation shall be One Hillion (\$1,000,000.00) Dollars, divided into One Hillion (1,000,000) Shares of the par value of One (\$1.00) Dollar each."

It being the purpose and intention of this amendment to render the stock of the Sabina Mining and Milling Company assessable pursuant to the provisions of the Idaho Statutes.

Resolved further that the chairman and secretary of the meeting be, and they hereby are authorized and directed to make, sign, verify and acknowledge any and all certificates of

proceedings required by law, and to file said certificates as required by law in the office of the County Recorder of Shoshone County, Idaho, and to secure a certified copy of such certificate as filed in the office of the County Recorder of Shoshone County, Idaho, and file such certified copy in the office of the Secretary of State of the State of Idaho, as required by the laws of the State of Idaho, and to do all acts and things that may be necessary to comply with the provisions of the laws of the State of Idaho applicable to and regarding amendments to the Articles of Incorporation of corporations.

That thereupon, and upon a motion to adopt the said resolution, the stockholders owning 623,130 shares of stock of the said corporation, being more than two-thirds (2/3) of all the issued stock of the corporation, voted for the adoption of said resolution, and stockholders owning 168,000 shares of stock voted against its adoption.

That the entire issued and outstanding capital stock of said corporation at the date of said meeting was 911,507 shares.
