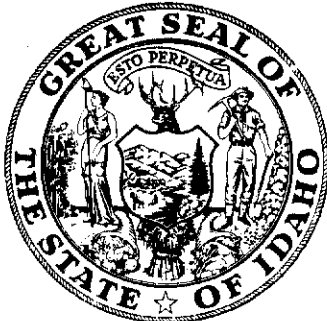

The undersigned, under the Idaho Business Corporation Act, amend the Articles of Incorporation for such Corporation as follows:

AMENDMENT: The name of the Corporation shall be changed from Camas County Title, Inc. to Tom and Marilyn Inc.

DATE OF ADOPTION OF THE AMENDMENT: The date of adoption of the amendment by the shareholders was November 22, 1996.
