KNOW ALL MEN BY THESE PRESENT that we, Ken Biery SR, Craig Marria, Leroy McDonough, Mike Ingram, and T.J. Sullivan, all of legal age and all citizens of the State of Idaho and the United States of America, having this day associated ourselves together for the purposes of forming a non-profit association pursuant to the provisions of Title 30, Chapter 3, of the Idaho nonprofit Corporation Act, inclusive, with all the rights, powers and privileges incident thereto and for that purpose do enter into the following Articles of Incorporation.

ARTICLE I

The name of this corporation shall be:

IDAHO STATE SKEET ASSOCIATION, INC.

ARTICLE II

The object and purposes for which this corporation is organized are as follows:

- (1) To organize a corporation within the State of Idaho in affiliation with and to affiliate with the National Skeet Shooting Association for the purposes of conducting, operating, maintaining and holding skeet shoots in accordance with the rules and regulations of the National Skeet Shooting Association.
- (2) To provide shooting grounds by way of lease, purchase, contract or otherwise for the holding and conducting of skeet shooting events; to lay out and prepare the same, to hold tournaments, trials or other meets and events at such times as are in accordance with the rules and regulations of the National Skeet Shooting Association and the rules and regulations thereof as may be adopted by this corporation for the members thereof residing within the State of Idaho,
- (3) To buy, sell and deal in goods, wares and merchandise of all kinds, including refreshments, equipment, apparatus and appliances, trophies, awards necessary or needful to carry out the provisions and undertaking of this corporation.
- (4) To do, contract, and undertake all these things that are authorized and allowed as provided by the provisions of Title 30 Idaho Code.

ARTICLE III

The principal place of business of this corporation shall be:

The duration of this corporation shall be perpetual.

ARTICLE V

This corporation is not organized for profit and has no authority to issue capital stock.

ARTICLE VI

The Executive Committee of the Corporation, serving as its board of directors, shall have general charge and control of its policies and property and handle all transactions and dispose of any and all matters which need not of necessity be brought before a regular meeting of the corporation. The Executive Committee which shall act until the annual meeting or until their successors are elected are as follows:

ARTICLE VII

Membership herein may not be restricted as result of race, creed or color, and any person, corporation or association may become a member hereof in compliance with the rules and regulations as provided by the By-laws and as fixed by the provisions of Title 30 Idaho Code. The origins of any member herein shall be as are fixed and provided by the provision of same.

ARTICLE VIII

Membership in this corporation shall be evidenced by a certificate of membership issued to each member thereof, which certificate cannot be assigned to affect a transfer thereof and no transferee can become a member of the association except be resolution of the Board of Directors and under such rules and regulations as they may prescribe or as prescribed by the By-laws. The By-laws of the corporation shall provide for the qualification of membership and the terms and conditions of admission.

ARTICLE IX

The rights and interests of all members shall be equal. Each member shall have one vote for all matters of business that come before the corporation for consideration by the membership. All members shall have those rights as provided by Title 30 Idaho Code and the By-laws of the corporation.
