ARTICLES OF INCORPORATION
OF
CANAM SPOKANE, INC.

The undersigned, C. LEE SEGUIN, a person over the age of twenty-one years, comes for the purpose of forming a corporation under the laws of the State of Washington, and in pursuant thereof does hereby sign and deliver to the Secretary of the State of Washington, the following Articles of Incorporation, and states as follows:

I

The name of this corporation shall be CanAm Spokane, Inc.

II

The duration of the corporation shall be perpetual.

III

The purpose of this corporation is to engage in the business of a collection agency, including those functions defined as those of a "collection agency" in Chapter 253, Section 1, Laws of the State of Washington, 1st Extraordinary Session of 1971; and to perform any and all functions generally connected with and included in the general pursuit of soliciting, collecting, buying, selling, and dealing in delinquent accounts, claims, or any other obligations for the payment of money or thing of value arising out of any agreement or contract, express or implied.

IV

1. The aggregate number of shares which the corporation shall have authority to issue is 2,500 shares.

2. Such shares are to consist of one class only and are to be without par value.

3. The aggregate value of all shares that are to have no par value shall be stated in affidavit filed pursuant to Revised Code of Washington Section 23A.40.050.

2 The power to adopt, alter, amend or repeal the By-Laws or
3 adopt new By-Laws shall be vested in the shareholders. The
4 By-Laws may contain provisions restricting the transfer of shares
5 of the corporation.




