

There are no suits pending against the corporation in any court.







WHEREAS, the secretary of the corporation reported that all 100% of the shares of outstanding capital stock in the corporation were represented in person; and,


WHEREAS, it is deemed advisable and for the best interest of the stockholders of the corporation that this corporation wind up its affairs and voluntarily dissolve;


