ARTICLES OF INCORPORATION

OF

PEND OREILLE SHORES OWNER'S ASSOCIATION, INC.

The undersigned, for the purpose of forming a non-profit cooperative association, pursuant to the applicable law of the State of Idaho relating to such associations, hereby certifies and states:

- 1. The name of the cooperative association is and shall be PEND OREILLE SHORES OWNER'S ASSOCIATION, INC., hereinafter referred to as the "Association."
- 2. The Association is and shall be a non-profit cooperative association, and is formed pursuant to, and in accordance with 1daho Code §30-301, et seq, known as the "Idaho Non-Profit Corporation Act." The Association does not contemplate pecuniary gain or profit to the members thereof.
- 3. Subject to dissolution in the manner provided by Idaho law regarding general business corporations, the life of this Association shall be perpetual.
- 4. Purposes for which this Association is formed are to provide maintenance and improvements on the common areas within Pend Oreille Shores, to provide architectural and aesthetic control of the common areas and improvements thereon, to make reasonable rules and regulations, and to promote the health,

safety and welfare of the residents living within Pend Oreille Shores, which is that certain tract of real property located in Bonner County, Idaho, more particularly described in Exhibit "A" attached hereto and made a part hereof. In order to further these purposes, this Association shall be empowered to:

- (a) Exercise all the powers and privileges, and perform all the duties and obligations of the Association as set forth in these certain documents entitled Pend Oreille Shores Owners
 Association, Inc. By-Laws, and Declaration of Covenants, Conditions and Restrictions for Pend Oreille Shores, A Recreational Condominium.
- (b) Fix, levy, collect, and enforce payment by any lawful means of all charges or assessments pursuant to the terms of the By-Laws, and to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Association, including all licenses, taxes or governmental charges levied or imposed against the property of the Association.
- (c) Acquire by gift, purchase, or otherwise, and own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use, or otherwise dispose of real or personal property in connection with the affairs of the Association.
- (d) Borrow money, and with the assent of two-thirds (2/3) of the members of the Association, mortgage, pledge, or encumber any or all of its real or personal property as security for money borrowed or debts incurred.

- (e) Dedicate, sell or transfer all or any part of the common areas to any public agency, authority, or utility for such pruposes, and subject to such conditions, as may be agreed to by the members. No such dedication or transfer shall be effective unless an instrument has been signed by two-thirds (2/3) of the members, agreeing to such dedication, sale or transfer.
- (f) Participate in mergers and consolidations with other non-profit associations organized for the same purposes, or annex additional residential property and common areas, provided that any such merger and consolidation shall have the assent of two-thirds (2/3) of the members.
- (g) Act as purchasing agent for goods and services for the members of the Association only.
- (h) In general, to carry on any other business in connection with the foregoing, and to have and exercise all of the powers conferred by the law of Idaho upon corporations, as qualified and limited by Idaho Code §32-301, et seq.
- (i) The foregoing clauses shall be construed as objects, purposes and powers; and it is hereby expressly provided that any enumeration of specific powers shall not be limited to or restrict in any manner the powers of this Association, except as provided in subparagraph (h) herein.
- 5. Every person or entity who is record owner of any unit, or units, which is located within the real property described herein, and is subject to the By-Laws referred to herein shall be

a member of the Association. Membership shall be appurtenant to, and may not be separated from ownership of any such unit, or units.

- 6. The Association shall be formed without capital stock, and the Association shall issue membership certificates to each member thereof. Said membership certificates shall be transferable only by means of the sale or transfer of ownership of a unit, or units, located in Pend Oreille Shores, which transfer of membership shall be approved by resolution of the Board of Directors of the Association, and in accordance with the By-Laws of the Association. Voting rights of each member of the Association shall be determined by the number of units within Pend Oreille Shores owned by said member. Any member may attend any meeting of the Association and may vote at such meeting in person, or may cast his/her vote through an agent duly appointed in writing, signed by the member and filed with the Association.
- 7. The affairs of the Association shall be managed by a Board of Directors, each member of which shall be a member of the Association and owner of a unit, or units, located within Pend Oreille Shores. The number of Directors of the Association shall be no less that three (3). The number of Directors may be changed by amendment of the By-Laws of the Association. Said Directors shall serve for a term of one (1) year and until their resepctive successors are elected, or until resignation or removal; provided that if any Director ceases to be an owner of a unit, or units, within Pend Oreille Shores, his/her membership and tenure as a

Director thereupon terminates.

- 9. These Articles of Incorporation may be amended by the membership of the Association, but such amendment shall require the affirmative vote of fifty-one (51%) percent of the entire membership.
- 10. The initial registered address of the Association shall be Star Route, Box 219, Highway #200, Hope, Idaho 83836, and the registered agent at that address is Richard Barnes.
- 11. The incorporator of this corporation is Richard Barnes of Star Route, Box 219, Highway #200, Hope, Idaho 83836.
