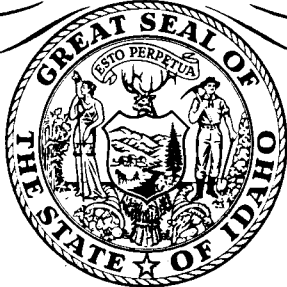


MEETING OF THE STOCKHOLDERS



All of the stockholders of said corporation appeared at said meeting. David J. Anderson was selected as Chairman of the Board for purposes of conducting the meeting with the stockholders.




