



# ARTICLES OF INCORPORATION

(Non-Profit)

The undersigned, in order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

Article 1: The name of the corporation shall be:

Lewis and Clark Parent Teacher Organization of Caldwell, Idaho Inc.

Article 2: The purpose for which the corporation is organized is:

The Corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code; including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the afore mentioned section 501(c)(3) of the Internal Revenue Code. Specifically, the organization exists solely to serve and supplement Lewis and Clark Elementary School through fundraisers, sales, funds and/or merchandise collected from donors or grantors, and time or services donated from local persons. In pursuance of these purposes it shall have the powers to carry on any business or other activity which may be lawfully conducted by a corporation organized under the Idaho State Non-profit Corporations Act, whether or not related to the foregoing purposes, and to do all things necessary, proper and consistent with maintaining tax exempt status under section 501(c)(3).

Article 8: Upon dissolution the assets shall be distributed:

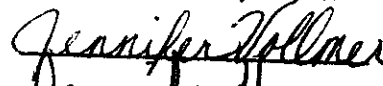
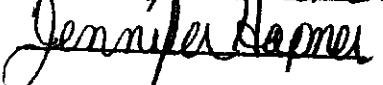
Exclusively for the purpose of the corporation or distributed to such organizations organized and operated exclusively for charitable purposes which shall, at the time, qualify as exempt organizations under section 501(c)(3).

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make

payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles or of any Bylaws adopted thereunder, this corporation shall not take any action not permitted by the laws which then apply to this corporation.
