ARTICLES OF INCORPORATION

OF

TITLEWEST, INC.

The undersigned, David D. Anderson, President and James E. O'Keefe, Secretary of Titlewest, Inc., an Idaho corporation, do hereby certify and respectfully represent as follows:

That on January 17, 1981, a special meeting of the stockholders of Titlewest, Inc. was held pursuant to 30 days written notice for the purpose of voting on an amendment to the bylaws and Articles of Incorporation to change the name of the corporation and increase the capital stock of the corporation. At that meeting, the following resolution to amend the Articles of Incorporation was unanimously adopted by all of the stockholders of the corporation, all of the stockholders being present and voting;

Resolved that Article I and Article V of the Articles of Incorporation of Titlewest, Inc., an Idaho corporation, be amended to read as follows:

Article I

The name of the corporation shall be First American Title Company.

Article V

The amount of the total authorized stock of this corporation shall be \$1,500,000.00 divided into 1,500,000 shares of \$1.00 par value each of common, nonassessable stock and the rights appertaining thereto will be in all respects equal and the shares may be increased or decreased as provided by the laws of the state of Idaho.

At the stockholders meeting on January 17, 1981, there were 100,000 shares of stock outstanding and 100,000 shares of stock entitled to vote at said stockholder meeting. At said stockholders meeting, 100,000 shares of stock was voted in favor of the foregoing amendments and that there were no votes cast against such amendments.


