**AMENDED  
ARTICLES OF INCORPORATION

The undersigned, acting as president of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**ARTICLE I**

The original Articles of Incorporation are being amended as per the resolution adopted by the Shareholders on the 2nd day of February, 1998. Said amendments are:

1. The name of the corporation shall be changed from Gull Pest Control, Inc., to **Gull, Inc.**, to accurately reflect the identification and spelling of the corporation;
2. Said amendment is to also reflect the current address of the registered office of the corporation of 1720 Franklin, Meridian, Idaho 83642; and
3. Shares shall be exchanged to provide each shareholder with an equal number of shares.

**ARTICLE II**

The corporation shall have perpetual existence.

**ARTICLE III**

The corporation is organized for the purpose of transacting, conducting, and carrying on any and all lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

**ARTICLE IV**

The aggregate number of shares which the corporation has authority to issue is 1,000 with par value of \$1.00 per share. There are 800 shares of stock issued and outstanding. All shares voted in favor of the amendments hereto.


