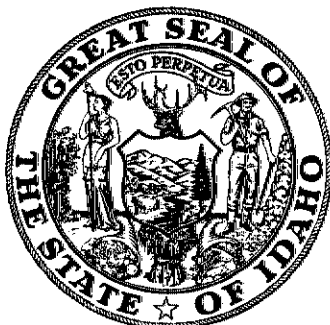
CERTIFICATE OF AMENDMENT OF

AMENDMENT TO THE ARTICLES OF INCORPORATION
FOR KIDSVIEW SCHOOL, INC.

We the undersigned, acting as the Board of Directors of the corporation in the Idaho Non-Profit Corporation Act, adopt the following amendment to replace the existing first article: The name of the corporation is Woodhaven Cooperative Elementary School, Inc.


The Amended Bylaws for Woodhaven (formerly "Kidsview School") dictate that "the corporation shall have one class of membership consisting of voting members whose voting power is limited to the election of board members at the annual election...the board of directors shall officially approve the consensus of the general membership, reached at [any] general meeting. The members thus vest their rights in the Board of Directors which they have elected, to conduct all affairs of the school, subject to the wishes of the consensus of the membership group.

In response to the consensus of opinion expressed by the general membership at the general meeting, I do hereby certify that this amendment was adopted by a unanimous "yes" vote from all seven of the seven Board of Directors of Woodhaven Cooperative Elementary (formerly 'Kidsview') School, Inc. on May 26, 1993.

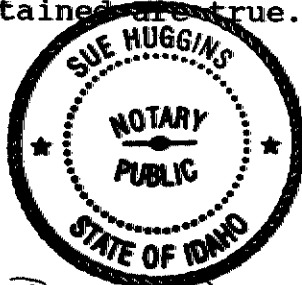
