

**ARTICLE OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
QUALITY PRODUCE OF BOISE, INC.**

KNOW ALL MEN BY THESE PRESENTS that at a special meeting held on the 28th day of December, 1989, pursuant to written Waiver of Notice and Consent of all of the stockholders of the corporation, the following Resolution was unanimously adopted by vote of approval of all of the stockholders of the corporation as follows, to-wit:
