

ARTICLES OF INCORPORATION,

of the Weston Creek Irrigation Company

KNOWN ALL MEN BY THESE PRESENTS:

That we, the undersigned, a majority of whom are free-holders, citizens, and residents of the state of Idaho have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the state of Idaho.

AND WE HEREBY CERTIFY:

FIRST. That the name of said corporation shall be Weston Creek Irrigation Company.

SECOND. That the purposes for which it is formed are for the irrigation of lands, domestic and agricultural, to pass by-laws, conduct the waters of Weston Creek upon the farms adjoining; to build and maintain culverts, bridges, dams, reservoirs, flumes, pipes, etc; to have and to hold real and personal property and for creating power for milling, electric or other purposes.

THIRD. That the place where the principal business of said corporation is to be transacted is Weston, Oneida County, Idaho.

FOURTH. That the term for which said corporation is to exist is Fifty years from and after the date of its incorporation.

FIFTH. That the number of Directors or trustees of said Corporation shall be five and that the names and residences of the Directors or Trustees, who are appointed for the first year, a majority of the members being present and voting, and to serve until the election and qualification of such officers, are as follows, to-wit:

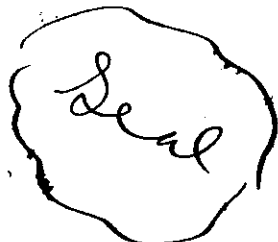
