(CONTINUED)

- ARTICLE 9:** No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2 herein.
- ARTICLE 10:** Notwithstanding any other provision of these articles, this corporation shall not, except to any insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
- ARTICLE 11:** Amendment of these Articles shall require the assent of two thirds (2/3) of the membership.
