## ARTICLES OF INCORPORATION

OF

SNOLINE EXPRESS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, ELAINE BORDEAUX and EVA LOU DIEBEL bot of roy, Latah County, State of Idaho, each and all citizens of the United States of America, of the age of majority, do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt and execute the following Articles of Incorporation, and do hereby certify and declare:

## ARTICLE I

That the name of said corporation is and shall be "SNOLINE EXPRESS, INC."

#### ARTICLE II

That said corporation is formed for the following purposes:

- (a) To engage in the general busing and transportation business and to do all things connected therewith and incidental thereto.
- (b) To exercise all authority and to perform all acts authorized under the provisions of Section 30-114 of the Idaho Code.

## ARTICLE III

That the location and post office address of the registered office of the corporation shall be:

## ARTICLE IV

The registered agent of the corporation shall be Eva Lou Diebel.

## ARTICLE V

That, subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual.
