

ARTICLE OF INCORPORATION
OF THE
BLAINE COUNTY LIVESTOCK GRAZING ASSOCIATION.

KNOW ALL MEN BY THESE PRESENTS:

First, Whereas, the undersigned are individuals who are engaged in farming and the raising of livestock,

And, Whereas, the undersigned are the owners in fee simple of certain lands and have acquired possession, by lease, of certain other lands, all situate in Blaine County, State of Idaho.,

And, Whereas, the undersigned desire to promote and protect said industries in so far as the same may lawfully be done,

Now, Therefore, we have voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho,

AND IN WITNESS WHEREOF;

FIRST.

That the name of this corporation is the "INCORPORATED BLAINE COUNTY LIVESTOCK GRAZING ASSOCIATION".

SECOND.

That the purposes for which this corporation is formed are; To buy, lease and otherwise acquire title to, and possession of, grazing and farming lands in Blaine County, Idaho, and such other places as may be necessary to carry on the objects of this corporation;

To purchase, or otherwise acquire, own, hold, use, cultivate, rent, lease, sell, convey, or otherwise dispose of lands for agricultural and stock purposes.

To buy, lease, build, construct, sell, contract for or otherwise acquire dipping vats, shearing plants and corrals, sheds, barns, fences and any and all conveniences as are necessary in the successful carrying on of the business of the corporation.

To acquire, by purchase or otherwise, water rights, and the right to the use of water for stock driving and other beneficial and useful purposes in said county and state, and in such other places where business of the corporation may require, and to do any, every and all things necessary to carry out the purposes of this corporation.

SIXTH.

That the place where the principal business of the corporation is to be transacted is Avery, Blaine County, Idaho.

SEVENTH.

That the term for which this corporation is to exist is **Fifty years**, unless sooner dissolved by process of law.

EIGHTH.

That the number of directors of the corporation shall be **eleven** and the names of those chosen are as follows:-

Gray, James H. Lane, Edward Cameron, Thos. C. Stanford, Ira Eldredge, Irvin Payne, H. L. Mitchell, Edwd. B. Arthur, James Laidlaw and Grover Marlott, one share each.
