**ARTICLES OF INCORPORATION**

The undersigned, being natural persons of legal age and acting as incorporators of a corporation under the Idaho Business Corporations Act, Title 30, Chapter 1, Idaho Code, adopt the following Articles of Incorporation for such corporation:

**ARTICLE I**

The name of the corporation is IDAHO SPUDCO, INC.

**ARTICLE II**

The period of the duration of the corporation shall be perpetual.

**ARTICLE III**

The purpose or purposes for which the corporation is organized are: to buy, sell, distribute, market and otherwise conduct business in relation to the potato market, and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**ARTICLE IV**

The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) shares with a par value of one dollar (\$1.00) per share. There shall be one (1) class of shares, all of which shall be common shares.

**ARTICLE V**

The address of the initial registered office of the corporation is 520 Legion Drive, Post Office Box 50217, Idaho Falls, Idaho 83405-0217, and the name of its initial registered agent at such address is MARVIN R. STUCKI.

**ARTICLE VI**
