We, the undersigned, hereby declare our intent to establish a non-profit association to be incorporated according the the provisions of Chapter 3, Title 30, Idaho State Code; and do hereby execute, subscribe and acknowledge the following ARTICLES OF INCORPORATION:

ARTICLE I

The name of the corporation shall be Nezperce Christian Church, Incorporated. The rules and regulations of this organization are set forth in their constitution and by-laws.

ARTICLE II

Nezperce Christian Church is a perpetual, non-profit organization made of an autonomous Christian society.

ARTICLE III

The purpose of which is an on-going task of winning people to faith in Jesus Christ, helping them grow in Christian faith and love, and engaging them in the common task of building the Kingdom of God.

ARTICLE IV

Membership in this corporation is to be based on membership in Nezperce Christian Church as determined by Article II of the constitution of this organization.

ARTICLE V

Officers of this corporation shall be composed of the regular church board of Elders, Deacons, and Deaconesses who are elected by members of the congragation at the church's annual meeting held on the last Sunday in June each year. The general church board will meet the first Sunday of each month. The dates of the monthly meeting and any special meetings are published in the church bulletin one week prior to the date and is announced to the congregation from the pulpit. The duty of the church board is threefold:

- To consider and recommend to the congregation general policies.
- 2. To transact business.
- 3. To direct the administration of the program of the church.

The general board makes reports to the congregation annually, or more often if items of special interest arise.

ARTICLE VI

This corporation shall own no capital stock; and the rights, interests and privileges of all members shall be equal, with none having a right to acquire a greater material or pecuniary interest in the assets of the corporation than any others.

ARTICLE VII

The initial registered office of this corporation is located at 307 4th Street; Nezperce, Idaho 83543. The name of the initial registered agent, who resides at that address, is George Kraus III, Minister.
