- (c) To purchase, sell, hold, acquire, own, mortgage, hypothecate, convey, improve, transfer, lease, exchange, trade and dispose of real and personal property.
- (d) To invest the capital of the company for any of the purposes aforesaid and in building or otherwise improving or adding to the market value of the lands or other properties from time to time acquired by the company.
- (e) In general, but in connection with the foregoing, the company may carry on any other business, and have and exercise all the powers conferred by the laws of the State of Idaho, upon corporations formed under the laws of said state; it being expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the general powers of the company.
