BRIAN BEAUTROW and MARIE FELCH, the undersigned, hereby certify that we are, and at all times hereinafter mentioned were, President and Secretary, respectively, of Christian Science Society, Boise, Idaho, a religious corporation organized and existing under and by virtue of the laws of the State of Idaho, with its registered office and location at Boise, Idaho; that on the 27th day of September, 1977, at 7:30 o'clock p.m. of said day, at a meeting of the Board of Directors of said corporation duly, legally and regularly held, the said Board of Directors determined to present at the regular meeting of the members of said corporation to be held at the office of the corporation at 11941 Ustick Road, Boise, Idaho, at 7:30 o'clock p.m., on November 14, 1977, the matter of considering and voting upon the question of amending Article I of the Articles of Incorporation of the corporation; that pursuant to the direction of said Board of Directors, the Chairman of the Board and the Secretary of the corporation caused public notice of the intention to amend the Articles of Incorporation of the corporation to be given by publication at least once a week for four weeks in the Idaho Statesman, a daily newspaper published in Ada County, Idaho, which notice designated the regular meeting at which it was intended to vote on the proposition of amending the Articles of Incorporation and stated the manner in which it was intended to amend said articles, as required by law.

THEREAFTER, pursuant to said notice, on November 14, 1977, at 7:30 o'clock p.m., at the office of the corporation at 11941

Ustick Road, Boise, Idaho, a regular meeting of the members of said corporation was held, at which meeting a quorum of members were present in person or represented by proxy; that said members constituted a quorum of members for the transaction of business; that the members present voted unanimously in favor of amending the Articles of Incorporation of this corporation in the particulars hereinafter set out in the resolution adopted by said members; that the following resolution was adopted by a unanimous vote of the members present in favor of said resolution; and that the following is the resolution hereinbefore referred to and adopted by said members at said regular meeting of the above-described vote:

WHEREAS, It is in the best interests of this corporation that the name thereof, to-wit, Christian Science Society, Boise, Idaho, be changed to Second Church of Christ, Scientist, Boise, Inc.; now, therefore;

BE, IT RESOLVED: That Article I of the Articles of Incorporation of Christian Science Society, Boise, Idaho, a corporation, be and the same is hereby amended to read as follows:

I.


"The name of this corporation shall be: Second Church of Christ, Scientist, Boise, Inc."
