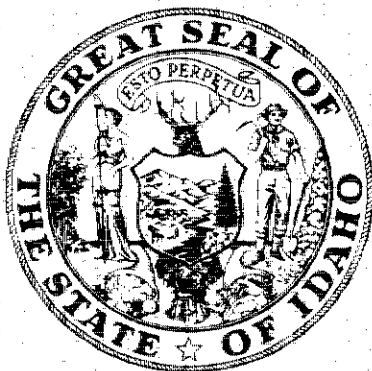

These are the Articles of Amendment of Christian Church at Boise City, Idaho, filed pursuant to Section 30-327, Idaho Code.


- (a) The name of the Corporation shall become University Christian Church (Disciples of Christ), and is changed from the previous name of Christian Church at Boise City, Idaho.
- (b) The change of name set forth in the previous paragraph was adopted by a majority vote of the Annual Congregational Meeting, July 2, 1986 and was unanimously approved by the Board of Directors on February 6, 1987.


