KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned natural persons of lawful age and citizens of the United States, for the purpose of forming a corporation pursuant to the provisions of the Idaho Business Corporation Act (Title 30, Idaho Code) do hereby certify as follows:

## **FIRST**

The name of the corporation is Prairie Drywall Supply, Inc.

#### SECOND

The corporation is to have perpetual existence.

# THIRD

The purposes and objects for which the corporation is organized include leasing and repair of golf cart equipment and transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act (Title 30, Idaho Code).

#### **FOURTH**

The aggregate number of shares which the corporation shall have authority to issue is 100,000. Such shares are to consist of one class only. The par value of each of such shares shall be \$.01 (One Cent), which stocks shall not be issued until fully paid for, and once so issued shall be non-assessable.

#### EIETH

All of the shares of stock issued shall be common stock, and all shares shall have equal value, without preferences, limitations or differences in relative rights with respect to other shares.
