Article 1: Corporation Name

Entity name Rocky Mountain Speech & Debate, Inc.

Article 2: Effective Date

The corporation shall be effective when filed with the Secretary of State.

Article 3: Purpose

The purpose for which the corporation is organized is: Educational

Article 4: Voting Members:

Article 6: IRS Designation

501(c)3 purpose for which the corporation is organized:

A. The corporation is organized and shall be operated exclusively for charitable, religious, literary, scientific and educational purposes as set forth in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (hereinafter the "Code").

B. The specific purposes for which the Corporation is organized include, but are not limited to, supporting the educational mission and activities of the Rocky Mountain High School Speech & Debate Team in Meridian, Idaho.

C. The Corporation shall have all the rights and powers that may be conferred upon non-profit corporations formed under the laws of the State of Idaho to carry out such purposes, including, but without limitation thereon, to receive gifts, devises, bequests and contributions in any form, including contributions in kind of real estate, and to hold, use, apply, sell, invest and/or reinvest the principal and/or income therefrom and/or distribute grant funds for the above purposes to any Qualified Organization.

D. For purposes of these Articles of Incorporation, the term "Qualified Organization" shall mean an organization described in Section 501(c)(3) and Sections 509(a)(1) or (2) of the Code.

E. No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to the Corporation's members, directors, officers, or other private persons, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles of Incorporation.

F. It is intended that this Corporation shall have the status of a corporation which is exempt from federal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code and which is other than a private foundation by reason of being described in Section 509(a)(1) of the Code.

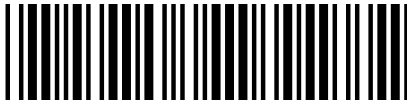
