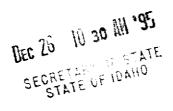

### ARTICLES OF INCORPORATION OF BUFFALO ELECTRIC, INC.

#### KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, being a natural citizen of the United States and of full age and majority, have this day and do hereby voluntarily associate myself together for the purpose of forming a corporation under the laws of the State of Idaho, and I do hereby certify:

#### ARTICLE I.

The name of this corporation shall be BUFFALO ELECTRIC, INC.

#### ARTICLE II.

The purposes and objects for which this corporation is formed is to generally engage in, do and perform, any enterprise, act or vocation permitted or authorized pursuant to the provisions of the Idaho Business Corporation Act and amendments thereto.
